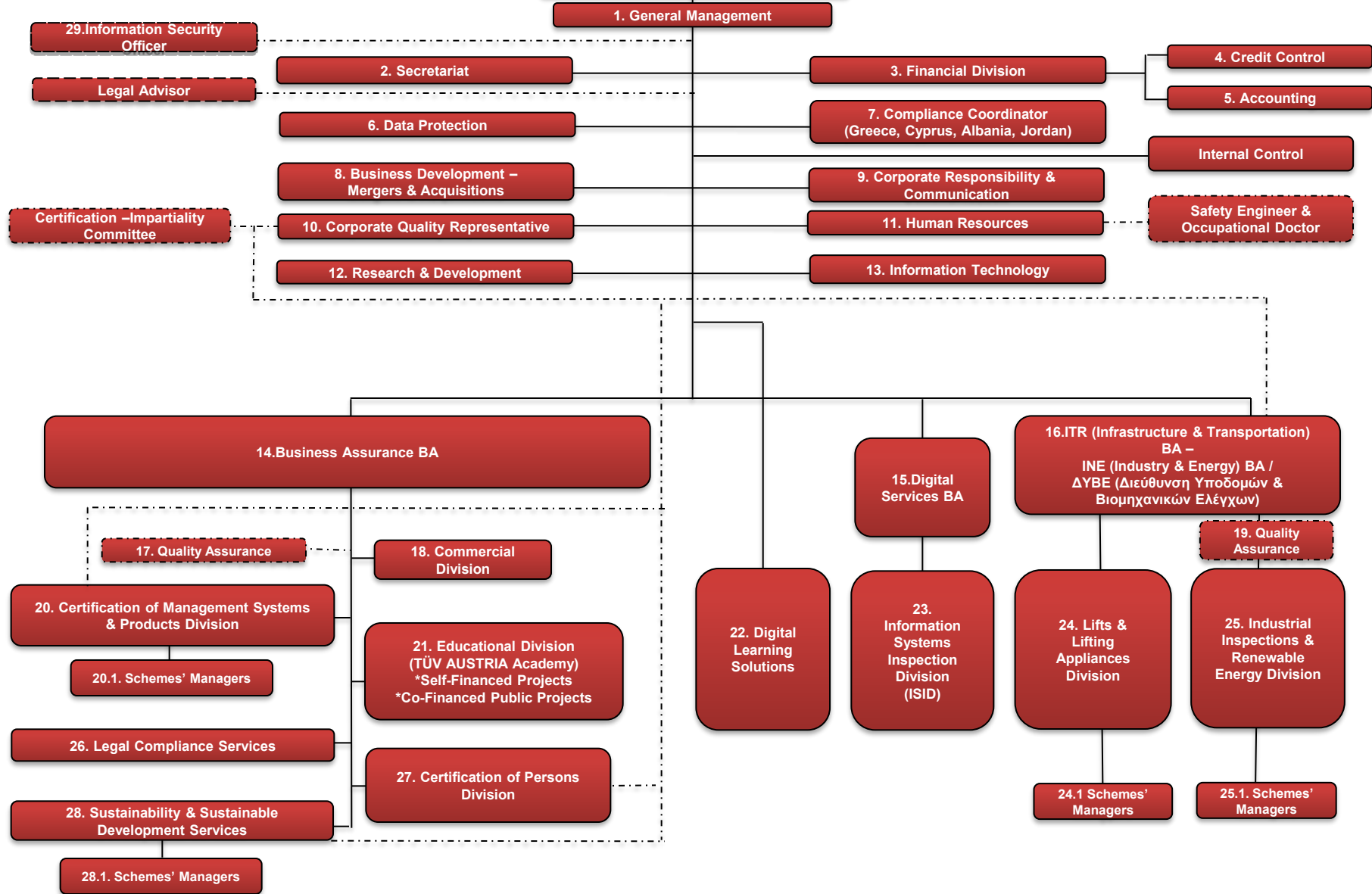
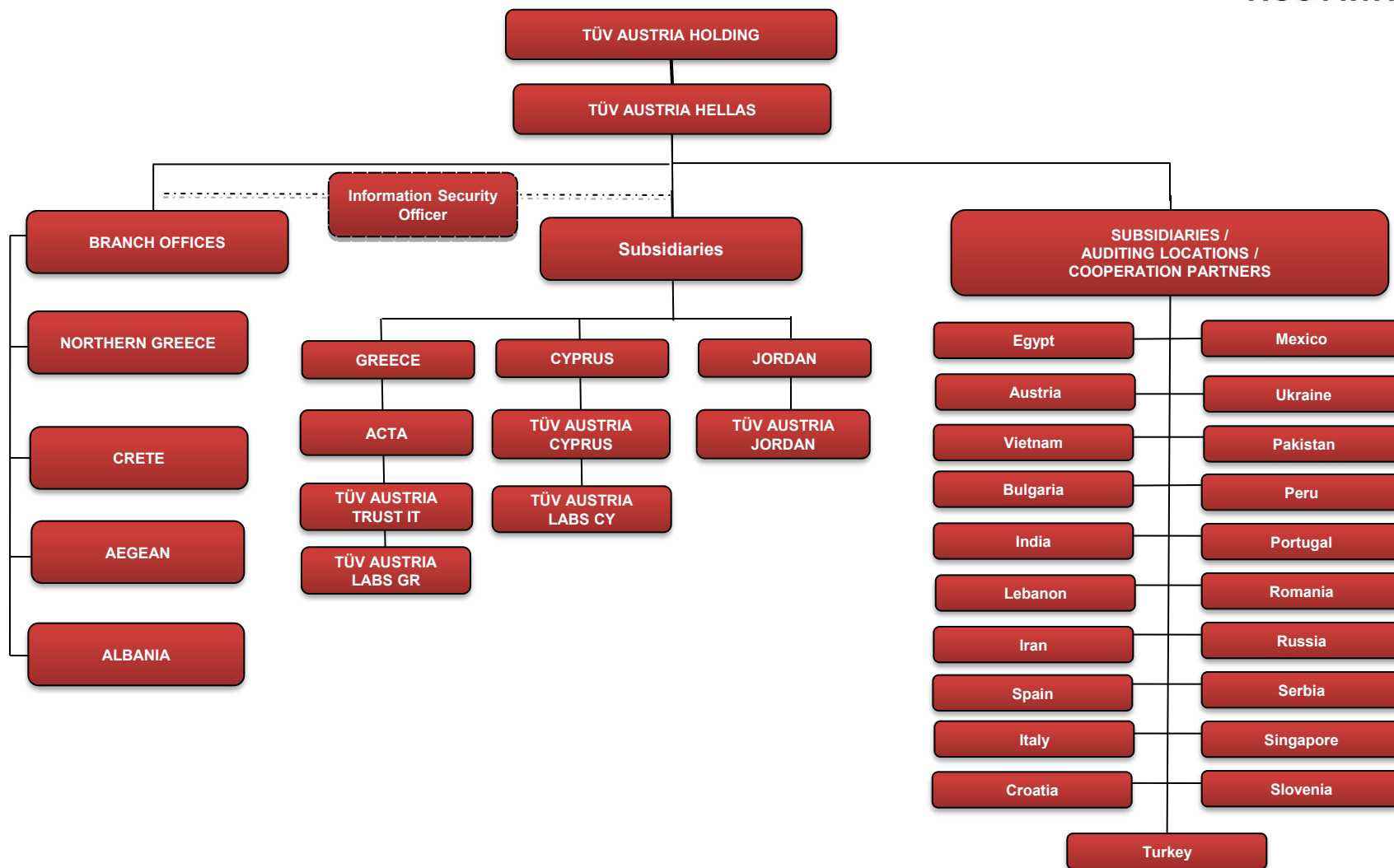


ORGANIZATION CHART
